A. Who can apply

- You must be 18 years of age or older and must have a Hong Kong address.
- You must be a holder of a Hong Kong Identity Card.
- You must be an **Eligible Employee** of the Group.
- You cannot apply for any Employee Reserved Shares if you are within the United States or a United States Person (within the meaning of Regulation S under the US Securities Act) or a legal or natural person of the PRC (other than Hong Kong, Macau and Taiwan).
- You must apply as an individual. Joint applications will not be accepted.
- Save as under the circumstances permitted by the Listing Rules, you cannot apply for Employee Reserved Shares if you are:
 - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;
 - a Director or chief executive officer of the Company and/or any of its subsidiaries;
 - a connected person (as defined in the Listing Rules) of the Company or a person who will become a connected person (as defined in the Listing Rules) of the Company immediately upon completion of the Global Offering;
 - a person who has applied for, or taken up, or received or been placed or allocated (including conditionally and/or provisionally) or will indicate an interest for, apply for or take up any International Placing Shares in the International Placing, or receive, be placed or allocated, or otherwise participate in the International Placing; and
 - an associate (as defined in the Listing Rules) of any of the above.

B. Lodge only one application for your benefit

Multiple applications or suspected multiple applications available to be rejected. Eligible Employees who have applied for Employee Reserved Shares on a PINK Application Form may also make an application for Hong Kong Offer Shares on a WHITE or YELLOW Application Form, or by submitting an application online through the designated website of the HK eIPO White Form (www.hkeipo.hk) or by giving electronic application instructions to HKSCC via CCASS. Eligible Employees may make an application for Employee Reserved Shares on a PINK Application Form and, in addition, will be entitled to apply for Hong Kong Offer Shares under the Hong Kong Public Offering but may not apply for or indicate an interest for International Placing Shares under the International Placing. Such Eligible Employees will receive no preference as to entitlement or allocation in respect of such further applications for Hong Kong Offer Shares under the Hong Kong Public Offering.

C. Allocation of Employee Reserved Shares

In order to enable Eligible Employees to participate in the Global Offering on a preferential basis as to allocation only, Eligible Employees are being invited to apply for a maximum of 448,000 Employee Reserved Shares, subject to the terms and conditions set out in the Prospectus and this Application Form. The Employee Reserved Shares are being offered out of the Hong Kong Offer Shares but are not subject to reallocation to the International Placing as described in the section headed "Structure of the Global Offering — Hong Kong Public Offering — Reallocation" in the Prospectus or the Offer Size Adjustment Option.

The 448,000 Employee Reserved Shares available for application by Eligible Employee on PINK Application Forms will be allocated to such applicants on a basis based on the level of valid applications received under the Employee Preferential Offering and the number of Employee Reserved Shares validly applied for within each application tier. The allocation basis will be consistent with the allocation basis commonly used in the case of over-subscriptions in public offerings in Hong Kong, where a higher allocation percentage will be applied in respect of smaller applications. The Employee Reserved Shares will be allotted if there are insufficient Employee Reserved Shares available to PINK Application Form applicants. If allotting is conducted, an Eligible Employee may be allocated more Employee Reserved Shares than others who have applied for the same number of Employee Reserved Shares. The allocation of Employee Reserved Shares to Eligible Employee will in any event be made on an equitable basis and will not be based on seniority or length of service of the Eligible Employee. No favour will be given to the Eligible Employee who apply for a large number of Employee Reserved Shares. Subject to the above, an application once made is irrevocable and applicants shall be deemed to have applied on the basis of this Prospectus as supplemented.

The applications for the Employee Reserved Shares will not be processed and no allocation of any such Employee Reserved Shares will be made until the closing of the application lists. The Company expects to announce the final Offer Price, the level of indication of interest in the International Placing, the level of applications in the Hong Kong Public Offering and the Employee Preferential Offering and the basis of allocation of the Hong Kong Offer Shares and the Employee Reserved Shares on Wednesday, 14 January 2015 in South China Morning Post (in English) and Hong Kong Economic Times (in Chinese) and on the websites of the Stock Exchange (www.hkexnews.hk) and the Company (www.sismobile.com.hk).

The results of allocations of the Employee Reserved Shares and the Hong Kong Identity Card numbers, passport numbers, of successful applicants will be made available through a variety of channels, including the websites of the Stock Exchange (www.hkexnews.hk) and the Company (www.sismobile.com.hk) as described in the section "How to Apply for Hong Kong Offer Shares and Employee Reserved Shares" in the Prospectus.

The Company will not issue temporary documents of title in respect of the Shares.
